

# NER300 RES first call awards as released by European Commission 18 Dec 2012

There is good consistency between the order of projects by funding rate ('Fund rate' in the table below) and the order by CPUP, which is the basis, as per Procedures Manual [Appendix 11.2](#), for determining the selection order of projects in the [12 Jul 2012 Staff Working Document](#). Mismatches in the ordering occur for the projects identified with **this marking**. They occur because the funding rate does not take account of national government subsidy flowing to the project, such as feed-in tariff payments, which, if it is present, pushes CPUP above the 'funding rate'.
